1. Relevant background information

Background information relevant to the PLAC III project:

The scope of the PLAC III project is to provide support to relevant national institutions in charge of alignment of national legal acts with the EU acquis and to contribute to further building of capacities of relevant national structures for successful carrying out of accession negotiations. The PLAC III project should achieve two results:

RESULT 1 - Enhanced compatibility of national legislation with EU legislation and its effective implementation

RESULT 2 - Enhanced capacities of the relevant national structures for successful carrying out of accession negotiations

In general, the project aims at fostering the process of accession negotiations of the Republic of Serbia by supporting effective alignment of national legislation with the EU acquis and its implementation and by further building the capacities of involved carriers of the EU integration process in the Republic of Serbia. After completion of the screening process in 2015, Serbian public administration has entered into much more demanding and obliging exercise of accession negotiations, whereby each step and every decision should result in approaching



actual membership in the EU. For this scenario to happen in accordance with planned dynamics, preparedness, adequate institutional capacity of public administration with highly competent staff is of crucial importance. In the core period of the negotiations, the PLAC III Project shall support local line institutions and negotiating structures both in performance of quality operational work in relation to the harmonisation process and in the effective coordination during various stages and phases in the process relevant to different negotiation chapters.

2. Background information in relation to Chapter 12 – Food Safety, Veterinary and Phytosanitary Policy

Negotiating Chapter 12 is one of the most demanding part of the EU acquis not only because of a wide range of legislation that have to be transposed and the demanding rules for animal and plant health, safety of food, feed and animal by products, but also for significant investments required by food establishments, as well as in agriculture and biosecurity measures.

The Republic of Serbia is intensively preparing for fulfilment the benchmarks regarding Chapter 12 - Food Safety, Veterinary and Phytosanitary policy with the support of IPA 2015 Project "Capacity building for the alignment with the acquis in the area of Agriculture, Rural Development, Food Safety, Veterinary and Phytosanitary policy." After definition of indicative list of Laws and in order to accomplish the first benchmark ("Serbia adopts framework legislation that complies with the acquis, enables full transposition of the acquis in this chapter and makes provisions for clear assignment of responsibilities, in particular for control bodies"), the MAFWM sent the first package of laws to the MEI on March 29, 2021 in order to obtain an informal opinion from the EC. The first package of laws was submitted to the EC by the MEI on 1 April 2021 and is consisting of the following: the Draft law on Animal Welfare, the draft Law on Plant Protection Products, the draft Law on Reproductive Material of Forest Trees, the draft Law on the acceptance of agricultural plant varieties and the draft Law on protection of plant breeders' rights. The second package of laws was sent to the EC also in April, 2021 for obtaining the informal opinion, which included: the draft Law on Animal Husbandry (a part related to zootechnics), the draft Law on General Use (a part related to materials and objects that come into contact with food) and the draft Law on Water for Human Consumption (done with the PLAC project assistance).

With the support of IPA 2015 Project "Capacity building for the alignment with the acquis in the area of Agriculture, Rural Development, Food Safety, Veterinary and Phytosanitary policy" the following laws are under preparation: The Draft Law on Official Controls (draft Rulebook on official controls on food is done by the PLAC III project), the Draft Law on Food Safety, the Draft Law on Plant Health, the Draft Law on Seeds and Planting Materials and the Law on Veterinary Matters. The draft Law on animal feed is under preparation with the IPA PLAC III project. On indicative list of laws to be drafted is also the Law for Animal by-products.

In order to accomplish the third benchmark ("Serbia presents to the Commission a classification of all food establishments and all establishments handling animal by-products based on the acquis, which will serve as a basis for a future National Programme for the upgrading of food and animal by-products establishments") the Governmental Order on classification and

upgrading of establishments for animal by products and derived products was adopted and published in the OG RS, No. 24/2021, March 19th of 2021. This Order is a precondition to start the categorization of animal by-products establishments.

Regulation (EC) No 1069/2009 and Commission Regulation (EU) No 142/2011 laying down requirements for animal by-products not intended for human consumption and derived products as a potential source of risks to public and animal health are the main legal acts to be transposed and implemented. Animal by-products regardless of their source, pose a potential risk to public and animal health and the environment. This risk needs to be adequately controlled, either by directing such products towards safe means of disposal or by using them for different purposes, provided that the strict conditions which minimise the health risks involved are applied.

In Republic of Serbia animal by-products are regulated by the Law on Veterinary Matters (Official Gazette RS, No 91/2005, 30/2010, 93/2012) and Rulebook on the manner of classification and handling of animal by-products, veterinary-sanitary conditions for construction of facilities for collection, processing and destroying of animal by-products, manner of implementation of official control and self-control, and conditions for cattle graveyards and pit grave (OG No. 31/11, 97/13, 15/15, 61/17) that is in line with Regulation (EC) No 1774/2002, which was repealed by the above mentioned EU regulations.

The PLAC III project's support is needed for amending the draft Law laying down health rules as regards animal by-products and derived products not intended for human consumption, which is prepared within previous Policy and Legal Advice Centre (PLAC) project. Republic of Serbia did not adopt this law yet. In the meantime, lot of amendments were adopted regarding Commission Regulation (EU) No 142/2011¹. Those amendments should be used for the improvements of the existing draft.

At present, there is no on going or planned assistance projects for the activities covered by this ToR.

3. Description of the assignment:

3.1. Specific objectives

The specific objective of this assignment is to provide assistance and support to the MAFWM in drafting the Law for animal by-product in line with requirements prescribed by Regulation (EC) No 1069/2009 and Commission Regulation (EU) No 142/2011

The Law will serve as a basis for adopting implementing legislation and transposing all provisions related to animal by-products and derived products.

3.2. Requested services

The Senior NKE in the area animal by-products is expected to provide the following services:

- Assisting the Ministry in fully harmonising the draft Law laying down health rules as regards animal by-products and derived products not intended for human consumption by transposing the requirements prescribed by Regulation (EC) No 1069/2009 and Commission Regulation (EU) No 142/2011 as amended²
- Assist the Ministry in drafting ToCs of Regulation (EC) No 1069/2009 and the Commission Regulation (EU) No 142/2011

3.3. Outputs

Senior NKE is expected to deliver the following outputs:

- Law on Animal by-products drafted
- ToCs drafted

3.4. Reporting

The SNKE shall provide the following reports by using the templates of the Project:

- Final Mission Report, not later than one week after the completion of tasks under this
 assignment. This report will include the description of all activities and outputs provided
 by the SNKE in the context of this assignment.
- A brief interim report only upon request of the PLAC III team: the TL and/or KE2

Submission of reports:

- A draft mission report shall be submitted to the Team Leader of the Project for review and comments by the end of the mission.

- The final version of the mission report, prepared in the agreed quality, shall be submitted to the Team Leader of the Project for review, comments and final approval.

- The reports shall be signed by the JNKE and the Team Leader, responsible for endorsing the reports.
- The reports and all prepared documents shall be submitted in hard copy and electronic version to the Team Leader of the project.

3.5. Specifics

The SNKE shall work under the guidance and follow the instructions of the Team Leader. The SNKE shall collaborate with the project team, other experts involved and the representatives of the relevant beneficiary institutions.

Each of the short-term missions, their timing and duration shall be agreed with the Beneficiary and the PLAC project team prior to each planned mission.

3.6. Expert input

3.6.1 Total working days

20 working days (WD) in total are planned for Senior Non-Key Expert for this assignment.

3.6.2 Period of the assignment and Starting day

It is expected that the work will be performed during several missions in the period from September 2021 until December 2021. However, the exact starting date will be agreed at a later stage.

3.6.3 Location/Place of assignment

The SNKE has to deliver 100% of the input in Serbia, unless otherwise agreed due to extraordinary circumstances (i.e. COVID-19). Home-based days are subject to a prior approval by the EU Delegation Project Manager responsible for the PLAC III project.

- Postgraduate professional experience in developing a system of official controls in line with the EU acquis requirements, gained in an EU member state, candidate or potential candidate country, will be an asset.
